Who you are contracting with:

UPDATE247 service is rendered by Holiday Zone Pty Ltd ACN 117 562 384 which is a private limited liability company, incorporated under the laws of Victoria, Australia located on 8/16 Taplin Street, Fitzroy North VIC 3068, Australia ("UPDATE247", "we", "us" and "our").

These terms and conditions and the provision of our services shall be governed by and construed in accordance with Australian Consumer Law in the Competition and Consumer Act 2010 (Cth); Any dispute arising out of these general terms and conditions and our services shall exclusively be submitted to the competent courts in the state of Victoria, Australia.
